Mosaic was founded in 1993 by Dr. Walter Nguyen, a former refugee who escaped an oppressive regime in Vietnam in 1982 and has dedicated the past 20 years to helping survivors of human rights abuses build new lives. Our staff comes from around the world, speaks 25 languages, and represents dozens of cultures and every major faith. Our work together is a celebration of diversity every day.

OUR CLIENTS

Like our staff, the women, men, and children we serve come from all over the world. Some of them arrived in the United States fleeing brutal war & persecution, others seeking to build better lives for their children and themselves. All have had their freedom threatened, whether by war, modern-day slavery, or violence in their own homes. They are testimonies to the courage and resilience of the human spirit.

OUR SUPPORTERS

Our volunteers and donors believe in the idea that freedom is a human right. They stand up for that idea every day by giving of their time and resources to ensure that survivors of human rights abuses in our community have opportunities they need to build new lives of freedom and hope. CLIENT ADVOCACY

Bilingual client advocates work with recently arrived refugees, survivors of family violence, and survivors of human trafficking to identify their needs and access vital services and resources within the community, functioning as interpreters and advocates. Mosaic staff is fluent in over 25 languages, enabling them to serve as a cultural bridge. Client advocacy gives survivors the tools they need to become self-sufficient.

SHELTER

Mosaic House is our shelter for women and children who have survived family violence or human trafficking. Residents receive the basic necessities including food, clothing, hygiene items, and medical care, while building the tools needed to be healthy and independent through on-site ESL classes, job and life skills training, counseling, and parenting courses. Children at the shelter receive help with school enrollment, immunizations, life skills, health care, tutoring and more.

Mosaic House was home to 270 women & children fleeing violence this year.

Mosaic feels like home, and not like a shelter. I like it here because of the diversity and because it helps me understand that I'm not alone. I can always get help from Mosaic.





LEGAL REPRESENTATION

Survivors come to Mosaic with legal needs encompassing both immigration and family law. They may need protective orders to keep them safe from their abusers, as well as representation for divorce, custody, and child support matters. Our attorneys help them with all of this, as well as immigration applications including U visas, T visas, and VAWA self-petitions. Our legal team partners with local law schools, firms, and pro bono attorneys to amplify our impact in the North Texas community and help more survivors access justice.

COUNSELING

Bilingual counselors utilize the Multicultural Counseling Model as well as play and art therapy to assist refugees, immigrants, and survivors of family violence and human trafficking in overcoming trauma and improving their emotional well-being.

In 2013, 365 people found hope and healing through our counseling program.



COLLABORATION & COMMUNITY EDUCATION

In addition to providing direct services to survivors, our team conducts outreach to build healthier, stronger families and communities and help stop human rights abuses in North Texas and beyond.

Mosaic's model of comprehensive, culturally sensitive services is nationally recognized. Our participation as an active member of local, regional, and national coalitions, task forces, and networks helps us build strong partnerships and inform policies intended to fight violence against women and human trafficking.

In 2013, our Multicultural Youth Substance Abuse Prevention Program provided information & education on substance abuse prevention to 252 students from culturally diverse populations in Dallas County.

Our HIV Early Intervention Program reached out to 286 people from multicultural communities in North Texas to connect them with the information and resources they need.

Our Human Trafficking Outreach Program provided education on human trafficking to more than 10,000 community members, including more than 2,900 law enforcement officers & social service providers identified as the most likely to encounter victims of human trafficking.

EVENTS

Launched in 2009, Mosaic's Champion of Human Rights Luncheon is an annual fundraising event that honors an individual for his or her extraordinary work bringing awareness to human rights abuses within the Dallas community. This year, 300 guests joined us at the Adolphus Hotel in downtown Dallas to honor Judge Roberto Cañas, of Dallas County Criminal Court No. 10. He has diligently worked to improve the legal system's response to domestic violence for many years and ensure justice for survivors.

We had a memorable afternoon listening to Abi Ferrin tell her story, hearing from a client personally impacted by Mosaic, and honoring Judge Roberto Cañas as this year's Champion of Human Rights. Guests enjoyed international cuisine, a cultural dance performance, and bid on exciting auction items..

The luncheon benefits our work with survivors of domestic violence and human trafficking and makes it possible for us to continue advancing our vision of combating human rights abuses in the Dallas community. We are so grateful for the support we receive at this event each year.







