The Shelter Advocate is essential to the residents' shelter experience, growth, and community living. The Overnight Shelter Advocate is responsible for providing advocacy, information, referrals, and related support and assistance to Mosaic House residents.

## **Essential Functions & Responsibilities**

- Answer the 24-hr hotline and screen calls for program admission and provide appropriate referrals and information for callers (victims and non-victims).
- Create a safe and welcoming environment for residents by greeting residents, responding to resident request(s), and ensuring residents are provided with high-quality emotional support.
- Implement procedures to ensure the safety of the building including but not limited to: camera system, interior and exterior areas, and includes communicating maintenance issues as needed.
- Maintain proper client and program documentation: communication logs, schedules, volunteer sign in/out sheets, confidentiality forms, and daily case notes, etc.
- Maintain applicable knowledge of Mosaic Family Services' policies and procedures.
- To ensure cleanliness and order of the shelter, Advocate will restock interior storage as needed and maintain order and sanitation to direct workspaces and common areas as needed.
- Assist with other duties as assigned by Supervisor or their designee.

  - Work hours as scheduled on time for adequate shift change and coverage.
